- One form for each Team or Group must be completed BY THE COACH confirming intention to enter its specific event at the 2019 CBTF International Cup/Grand Prix Qualifier.
- By signing & submitting this form along with a \$200 non-refundable deposit, the Team/Group is indicating that it fully intends to enter the event it qualifies for at the 2019 WBTF International Cup/Grand Prix and shall attend that competition.
- The Team/Group is financially responsible for all costs incurred in traveling to the International Cup/Grand Prix Qualifier and the International Cup/Grand Prix.

SPECIAL CIRCUMSTANCES AFFECTING TEAMS AND GROUPS:

Between declaration deadline & Qualifier date – should the number of members in a Group decrease so that it is no longer a Group (but is able to compete as a Team), the Team shall be permitted to compete at the Qualifier.

Between the Qualifier date and before the International Cup/Grand Prix entry deadline – should the number of members in a Group that has qualified decrease so that it is no longer a Group (but is able to compete as a Team), the Team shall be permitted to compete at the International Cup/Grand Prix (provided the maximum number of entries has not been met)

Between International Cup/Grand Prix entry deadline and departure date – this situation will be assessed by the CBTF Executive.
