**Competition Directors:** Judges must have the ? mark under 'Eligible for Head Judge' in order to be assigned Head Judge duties at any CBTF-sanctioned competition during the 2023-24 season. *This has been updated based on the 2024 What's New Webinar participation.*

In order to be eligible to accept a Head Judge position at any given competition, a judge must:

- be certified in all modules for all events offered at the specific competition, AND
- must have participated in recent Judging Updates and Webinars, including the 2024 What's New Update, AND
- must have a minimum of three years recent active judging experience

**NOTE:** The Head Judge selected for a competition must be certified in all disciplines offered at that competition.
