Privacy Policy

The Canadian Baton Twirling Federation (CBTF) recognizes your right to privacy and is strongly committed to protecting the privacy of all visitors to our web site. Information of a Non-Personal Nature

As a general policy, with the exception of IP addresses, no personal information is automatically collected from visitors to the CBTF's web site. Some services of the CBTF web site are available to web site members only. To become a member of the CBTF web site, you must be a member of the Canadian Baton Twirling Federation. We may use personal information you have provided on your CBTF membership application to create your CBTF web site account.
