General Information

1. Please submit with **1 Club Cheque** or money orders payable to **OBTA**. Post-dated cheques are accepted but must be dated no later than **January 16, 2020**. NSF Cheques will be subject to a \$25.00 service charge. NSF cheque amount, and service charge must be paid in cash or money order no later than 1 week prior to the event. 1. If you wish **confirmation that your entry** has been received, please include a stamped self-addressed envelope and a photocopy of your entry form or an email address for email confirmation. **Refunds** will be given only if athlete is unable to compete and a medical certificate is provided.

2. Current CBTF Rules and Regulations, effective January 1, 2020 will be in effect and strictly enforced.

3. Judges' decisions are final. Tabulated results are final 48 hours after the completion of the competition.

4. All athletes must be registered members in good standing with CBTF/OBTA for the competition season. CBTF membership numbers must be indicated on the entry form.

5. In order for an athlete/group to compete in a CBTF sanctioned competition, all athletes must be coached by currently registered CBTF certified (minimum) Level 2 Coach (Competitive).

6. Athlete/Group must declare any medical support/brace necessary for injury prevention as deemed necessary by a physician. Copy of medical certificate must accompany entry.

7. Order of events are: Pompom teams, Dance Twirls, Twirl Teams, Pre-Groups, Freestyle Teams, WBTF Groups, Short Program, Compulsories, Basic March, Forward Motion, Duets, Solo, Medley, Solo Dance, 2-Baton, 3-Baton, & Freestyles/Pairs. Pre-Events will precede the full event it represents. (Events may need reorganizing once entries are in)

8. The Competition director reserves the right to make last minute changes. Notice of changes will be provided to everyone affected.

9. All results will be posted and Awards are as follows: Groups 1st to 3rd, Individuals 1st to 3rd (1st to 5th in divisions with 10 or more athletes). All C and BN divisions from 7-11 yrs. of age are evaluated under the CBTF Grading system and are not scored, they will receive a bronze, silver, gold or diamond medal. All participants in Basic March, Forward Motion and Pre-Events will receive their CBTF Ribbon.

10. Special Needs lane will be made available on request

11. Athletes' Participation/Gym Fee – All athletes will be required to pay a participation/gym fee with entry. No fee will be charged at the door and one set system per athlete will be provided for each athlete that day.

12. Medical assistance/ First Aid will be on-site.

13. Warm-up area will be provided if possible.

14. Doors Open at 8:00am. Competition begins at 9:00 a.m.

15. Refreshments and food will be available on site, as well as lots of fun activities for the athletes!

16. We may be Flashing scores after each individual event, remembering tab-room will take penalties off after flashing.

17. CBTF Risk Management Policy

A. The Competition Director or designate and/or the Head Judge shall have the authority to immediately stop the competition whenever a risk factor related to safety becomes evident.

B. If this situation occurs during individual competition, the competition on the lane where the situation occurs shall be stopped on that lane only by the competition director and/or the judge judging that event.

C. If an athlete must leave the competition to seek outside medical assistance because of a situation that has occurred during a competition, the athlete shall require a Medical Certificate stating that he/she may continue competing at that competition.

D. If the situation involves a medical injury or illness (that does not require outside medical assistance), the Competition Director, in consultation with authorized medical personnel, shall determine whether the athlete(s) may be allowed to continue competing.
